Safety and Warning Instructions

- Ensure ventilation slots are not blocked to maintain optimal air circulation and cooling.
- Do not place the device near heat sources or in direct sunlight.
- Do not use electrical devices or heating elements inside the unit.
- Never clean the device with a water jet or high-pressure cleaner to avoid the risk of electric shock and short circuits.
- Do not use damaged cables or plugs. Replacement must be performed by qualified personnel only.
- Always switch off the device and disconnect it from the power supply before cleaning, maintenance, or repair.
- The refrigerant is flammable; if the cooling circuit is damaged, ventilate the room thoroughly and avoid open flames.
- Children must not use the device unsupervised or play near it.
- The device is designed exclusively for storing food; any other use may cause damage and void the warranty.
- Handle the display case with care (fragile glass). Do not lean heavy objects against it or strike it.
- Immediately stop operation if visible damage or malfunctions occur, and contact qualified personnel.
