- Avoid wearing loose clothing or having open hair to minimize the risk of entanglement.
- Turn off the motor immediately if unusual noises or vibrations occur, and have it inspected.
- The device is intended solely for its designated purpose of cutting food; any other use is prohibited.
- Unplug the device during extended pauses or when not in use to ensure safety.
- Dispose of packaging materials properly and keep them out of reach of children.
- Repairs and component replacements must only be carried out by authorized personnel.
