Safety and Warning Instructions

- Place the device only on a stable, level, and non-slip surface.
- Ensure that the mains voltage corresponds to the information on the nameplate.
- After transport or tilting the device, allow it to stand upright for at least 12 hours before switching it on to avoid damage to the cooling system.
- Children and unauthorized persons must not operate the device or be left unsupervised near it.
- During operation, parts of the device, such as the compressor, can become very hot – risk of burns.
- Do not fill the beverage containers with hot liquids, as this may deform the containers and damage the device.
- Never immerse the device in water or clean it with a water jet to avoid the risk of short circuits and electric shock.
- Do not block or obstruct the device's ventilation slots to ensure optimal air circulation.
- Always switch off the device, disconnect it from the power supply, and allow it to cool completely before cleaning or maintenance.
- The refrigerant is flammable; in case of a leak, ventilate the room thoroughly and avoid open flames.
- Repairs must only be carried out by qualified personnel.
- Do not use extension cords or power strips unless they meet current safety standards.
- Regularly clean the condenser and remove dust to maintain the device's efficiency.
- The beverage containers are not dishwasher-safe and should be cleaned manually to prevent damage.
- Safely dispose of packaging materials, as they pose a suffocation hazard for children.
- Immediately stop operation if visible damage or malfunctions occur, and contact the retailer or qualified personnel.
- The device is designed exclusively for cooling and dispensing cold beverages; any other use may cause damage and void the warranty.
